# ABOUT ECHO INDIA



ECHO India's innovative 'Hub and Spoke' Model of capacity building involves a team of experts serving as the hub, mentoring and training the spokes, who are a cohort of learners. This approach is supported through a cutting-edge digital infrastructure, 'iECHO' that enables scalable and sustainable capacity building in a cost-effective manner. Together, we strive to create positive change and drive meaningful impact in the communities we serve.

## THE ECHO MODEL OF LEARNING



ECHO India aims to impact the lives of 400 million people in India by the end of 2025. To achieve this goal, in collaboration with our partners, we have launched over 350 hubs and implemented 800 capacity-building programmes that cover more than 30 disease areas.

These programmes have witnessed over 1.5 million attendances from healthcare workers and educators across the country, with remarkable results. The ECHO Model's 'All Teach All Learn' framework has been proven effective and has been validated by over 500 peer-reviewed articles published in renowned national and international journals, such as The New England Journal of Medicine and The Lancet. ECHO India has joined forces with the Ministry of Health and Family Welfare (MoHFW) and 28 state National Health Missions (NHMs), municipal corporations, nursing councils, and esteemed medical institutions across India.

Some of our leading institutional partners include AIIMS (All India Institute of Medical Sciences), NIMHANS (National Institute of Mental Health & Neurological Sciences), Pallium India, NITRD (National Institute for Tuberculosis and Respiratory Diseases), NICPR (National Institute of Cancer Prevention & Research), Tata Memorial Hospital, and PGIMER (Post Graduate Institute for Medical Education & Research). 



Since 2020, ECHO India has launched programmes to enhance nursing skills, offering specialized training in areas like Infection Prevention, COVID-19 Advocacy, Mental Health, and more. These initiatives have gained support from partners like the Tamil Nadu Nurses and Midwives Council, Pediatric and Neonatal Nurses Forum India, and the Trained Nurses Association of India, addressing the vital need for continuous learning and upskilling among nurses.

ECHO India has facilitated several learning programmes aimed at upskilling the nursing fraternity. These initiatives span diverse focus areas like Infection Prevention & Control (IPC), COVID-19 Vaccination & Advocacy (VCAP), Mental Health, Obstetrics, and Palliative Care. Some of ECHO India's notable partners include the Nagaland Nursing Council, the Nursing Teachers' Association of India (NTAI), Gujarat Nursing Council, and Trained Nurses Association of India (TNAI).


# **TUBERCULOSIS**

In India, tuberculosis (TB) is a significant health concern driven by a large population, overcrowded living conditions, and limited healthcare access. Drug-resistant TB poses a substantial challenge due to extended treatment, limited drugs, and diagnostics, along with delayed diagnosis and insufficient treatment. Stigma surrounding the disease further hampers management, necessitating improved healthcare, diagnostics, awareness, and stigma reduction.

A comprehensive approach is crucial in the fight against TB in India, emphasizing the need for early detection and diagnosis, patient-centered care, stigma reduction, multisectoral collaboration, and community involvement, particularly in high-burden areas.

In line with the National TB Elimination Programme's (NTEP) objective to eliminate TB in India by 2025, ECHO India supports its partners to enhance the skills of healthcare workers. Collaborating with the National Institute for Tuberculosis and Respiratory Diseases (NITRD), ECHO fosters comprehensive TB control, covering diagnosis, treatment, training, and research. This government-recognized partnership has elevated treatments and reduced the TB burden. ECHO also collaborates with State TB Training and Demonstration Centres (STDCs) and State Tuberculosis Cells (STCs) nationwide.

The ECHO Model is now an integral part of the revamped NTEP, empowering healthcare providers across all TB-related institutions and initiatives, from primary clinics to advanced hospitals. Through collaboration with national and state-level institutions, the aim is to empower the dedicated TB healthcare workforce, all in pursuit of the ambitious goal of eliminating TB from India by 2025.







The prevailing stigma surrounding mental health issues silences those affected, hindering their ability to seek help and receive proper treatment. This societal bias not only delays intervention but also fosters discrimination and exclusion, further diminishing the well-being and quality of life for those dealing with mental health challenges. Further obstacles like limited access to care, low awareness, societal misunderstandings, and a shortage of mental health professionals, especially in remote areas can deter individuals from seeking assistance, resulting in delayed or insufficient treatment and worsening the impact of mental health issues on their overall well-being.

ECHO India is currently collaborating with a diverse group of stakeholders, dedicated to advancing mental health initiatives and enhancing the proficiency of medical professionals in mental healthcare delivery. Our esteemed partners include renowned institutions such as the National Institute of Mental Health and Sciences (NIMHANS), Society for Mental Health in Low and Middle-Income Countries (SoMHiL), Mind India, and the Directorate General of Health Services (DGHS), Ministry of Health and Family Welfare (MoHFW).

### CANCER

Cancer has emerged as a significant health challenge in India, attributed to various factors such as lifestyle habits, tobacco consumption, and limited healthcare infrastructure, particularly in underserved regions. Late detection of cancer remains a key challenge, primarily due to a lack of awareness and limited access to screening facilities. This often results in the diagnosis of advanced stages of the disease, making treatment more difficult and reducing the chances of successful outcomes.

The current priorities for capacity building in cancer care include early detection, equitable access to treatment, comprehensive education and awareness, palliative care, and multidisciplinary care. Focusing on these aspects is crucial for enhancing cancer care, reducing mortality, and improving the quality of life for cancer patients.

In pursuit of these priorities, ECHO India collaborates with renowned institutions like the Tata Medical Centre, the National Institute of Cancer Prevention and Research (NICPR), Adyar Cancer Institute (WIA), CanKids KidsCan, PHO India, and several state National Health Missions (NHMs) to enhance cancer care.

A notable initiative facilitated by ECHO is NICPR's programme on Cancer Screening and Cytology-Based Cervical Cancer Screening for Medical Officers (MOs), which provides comprehensive training on cancer epidemiology, diagnosis, and management. Additionally, in partnership with ECHO India, CanKids runs the CanKids-ECHO Care Plan Project, dedicated to creating care plans for children battling cancer, ultimately elevating treatment standards and supporting social workers.

### **MATERNAL & CHILD HEALTH**

In the heart of India's progress, the well-being of its mothers and children stands as a sacred promise for the nation's future. A vital cornerstone of the nation's well-being, prioritizing the health of mothers and children not only reduces mortality rates but also fosters economic productivity and social development. This commitment aligns with SDGs global development goals and signifies India's dedication to improving healthcare access and infrastructure. By investing in the well-being of its mothers and children, India is sowing the seeds of a healthier, more prosperous, and equitable future.



To enhance maternal and child health in India, it is crucial to ensure accessible and qualitative healthcare services, particularly in underserved regions. Promoting regular antenatal and postnatal care for mothers, strengthening immunization programmes, and expanding education and awareness efforts are paramount. Additionally, nutritional support, family planning services, skilled birth attendance, and community health workers play a pivotal role.

ECHO India, in collaboration with state NHMs, facilitates capacity-building initiatives, including Continuous Medical Education (CME) sessions and skill-building workshops. These programs focus on enhancing clinical skills, promoting evidence-based practices, and boosting knowledge in critical areas like antenatal care, safe delivery practices, emergency obstetric care, newborn care, and child health interventions.

In partnership with ARTIST for Her, ECHO India facilitates mentorship of healthcare assistants to improve healthcare outcomes for mothers and newborns. Additionally, in collaboration with Every Infant Matters (EIM), ECHO India enables the training of Auxiliary Nurses and Midwives (ANMs) in the Northern and Eastern regions of Sikkim, with a focus on comprehensive maternal and newborn care.

### PALLIATIVE CARE

Palliative care, a vital component of healthcare aimed at improving the quality of life for individuals battling serious illnesses, confronts several challenges in India. Primarily concentrated in urban areas, there is limited awareness regarding its benefits and scope, impeding its broader accessibility and impact. These challenges are exacerbated by insufficient infrastructure and the pressing demand for additional trained palliative care professionals, encompassing doctors, nurses, and social workers.

The importance of palliative care lies in its ability to enhance the quality of life for individuals facing serious illnesses, particularly those with advanced or terminal conditions. It provides relief from symptoms, emotional support, and a holistic approach to care, ensuring patients and their families experience dignity, choice, and improved well-being during challenging times. Additionally, it reduces emotional and financial burdens, enhances patient satisfaction, and humanizes the healthcare system, emphasizing the importance of a dignified and compassionate end-of-life journey.

As a step forward, a comprehensive approach needs to be undertaken, starting with integrating palliative care into primary healthcare services and upskilling and training the palliative care workforce, especially in underserved regions. To support this, ECHO India collaborates with organizations such as Pallium India, CanSupport, the Trivandrum Institute of Palliative Sciences (TIPS), Dr. Bhubaneswar Borooah Cancer Institute (BBCI), and DNipCare to facilitate a range of initiatives.

TIPS, in partnership with ECHO India since 2017, has conducted over 100 capacity-building programs, focusing on palliative medicine, pain management, and grief support. These initiatives have successfully upskilled and mentored a diverse range of healthcare professionals, from doctors and nurses to physiotherapists, counselors, medical students, and allied health providers.

# COVID-19

The COVID-19 pandemic has profoundly impacted India, creating challenges in public health and the economy. During the pandemic, healthcare and frontline workers were tirelessly providing critical care and support to those affected by the virus. It called for building capacities of our frontline workforce to deal with healthcare emergencies.

Through collaborations with central and state governments, to date, ECHO India has aided the mentorship of more than tens of thousands of healthcare professionals, including doctors, nurses, and Community Healthcare Workers, providing ongoing support for the COVID-19 response. These initiatives have been essential for addressing diverse health issues and preparing healthcare workers to tackle future concerns.

## Infection Prevention and Control (IPC)

ECHO India partnered with public health entities to train 5,500 nurses in Infection Prevention & Control (IPC) during the pandemic. The programme featured a curriculum covering IPC and soft skills, and offered short weekly sessions to accommodate nurses' demanding schedules. Training effectiveness was closely monitored. The collaboration established 15 hubs for future training, conducting 200 IPC and 60 soft skills sessions, and emphasized nurses' critical role in COVID-19 management amid a global crisis.



# COVID-19 Vaccination Confidence and Advocacy Programme (VCAP)

The COVID-19 Vaccination Confidence & Advocacy Programme (VCAP) is dedicated to empowering healthcare professionals in underserved areas to address COVID-19 vaccine hesitancy effectively. Its mission involves equipping healthcare workers with the necessary skills to confidently promote COVID-19 vaccination and enhance their capability to detect and manage vaccine-related adverse events. The programme has been conducted in partnership with NHM Nagaland, NHM Arunachal Pradesh, Kolkata Municipal Corporation (KMC), the Directorate of Public Health in Tamil Nadu, Maharashtra Nursing Council, and Sikkim Nursing Council.



### Community Healthcare Workers (CHWs)

ECHO India launched a vital capacity-building initiative designed to empower Community Health Workers (CHWs) in tackling the complex healthcare challenges arising from the COVID-19 pandemic. The programme was conducted in partnership with KMC, West Bengal, the Directorate of Public Health in Tamil Nadu, NHM Sikkim, and NHM Himachal Pradesh, and provided mentorship to thousands of CHWs, equipping them with knowledge in both COVID-19 management and Comprehensive Primary Healthcare.



### Long-COVID

Long COVID refers to a condition where individuals who have recovered from the acute phase of COVID-19 continue to experience a range of persistent and new symptoms for weeks or months after their initial infection. It can significantly impact an individual's quality of life and therefore needs ongoing medical diagnosis, support and treatment.

ECHO India facilitated various initiatives, including a webinar series, to bridge the capacity gap among healthcare providers to monitor patients, identify Long COVID complications and provide appropriate care, thereby improving healthcare service delivery with respect to Long COVID syndrome.

### **Upskilling Educators for Better Learning Outcomes**






